Marin del Centro has a Super Troop patch program, which encourages and recognizes troops that complete a well-rounded Girl Scout program, rich in traditions. Achieving Super Troop status requires troops to participate in various activities throughout the Girl Scouting year – many of which you will be participating in anyway! Being a Super Troop means all the girls in your troop must participate in the majority of the Super Troop requirements. Where girls are required to earn Try-It's/Badges, they do not have to be the same for every girl. Additionally, every girl in your troop must participate in at least two service projects.

Use the worksheet throughout the year to record your activities. As you plan your troop activities for the year, schedule in the Super Troop items. The worksheet needs to be turned in by May 15th and all activities must be completed by July 31st. Note any plans or activities you will be doing during that time to meet the requirements.

The ACT committee will review the worksheets at the end of the year. Hint: Keep the worksheet current to avoid year-end panic!! After the worksheet has been reviewed, ACT can order the Super Troop patches.
